#### How to voice concerns about <u>air traffic noise</u> over Milton – It's easy!

- Call Massport's Noise Complaint Line: (617) 561-3333. It is available from 7:00 a.m. to 4:30 p.m., Monday – Friday. If you call before or after hours, you can leave a message or ask to speak to someone in Massport's Operations Center. They will log your complaint and forward your information to the Noise Abatement Office for follow up.
  - Ask for a written confirmation
- File a noise complaint on Massport's site <a href="http://www.massport.com/environment/">http://www.massport.com/environment/</a> environmental reporting/Noise%20Abatement/NoiseComplaints.aspx
- Whether calling or online, request a written confirmation. PLEASE SAVE THEM FOR DOCUMENTATION
  - File as often as you are motivated to do so; some file several times a day when air traffic over Milton is non-stop
  - Written confirmations are sent by mail and arrive a month or so after the complaint
  - o If you are so inclined, please keep a journal which will include, date, time, and observation.

### Why voice your concerns?

- The more complaints that Massport and the FAA continuously receive the greater the impact. The more residents who complain the better, as Massport counts the number of unique residents who report a complaint per year as well as the total number of complaints.
- These complaint numbers can be reported to and used by local officials and civic leaders to try to reduce air traffic noise over Milton
- If no one complains then Massport and the FAA assumes the noise does not affect the community and residents are "willing to put up with it".
